- 2. One skill beginning above the bar, swinging through the bottom, and ending on top (i.e. baby giants, giants, undergrip cast, back uprise)
- 3. Salto dismount

Pommel Horse:

Require the two scissors to be consecutive. Stops in between will not earn requirement.

Parallel Bars:

Somersault dismount must be performed <u>through</u> a support (Fly-away will not receive credit)
