<u>Rob Miller:</u> The following statement was given by Chad Downie concerning Rob Miller:

5/11/11

To the members of the IHSGCA:

I became aware that the Hall of Fame Committee rejected nomination Rob Miller into our Hall of Fame. Although this disappoints me because of the personal relationship I had with Rob and have with his family, it concerns me that the committee is not acting in the true commission of their task nor in the best interest of our association. I do not blame the committee for seeing the nomination of Rob Miller in the light of the rules set out by our IHSGCA constitution; that is, I am sure the committee applied the rules guiding nomination fairly, and thoughtfully. Though a four year high school gymnast, a two time captain or our team, a state qualifying team member in 2002, and an individual event finalist, after high school Rob Miller did not contribute directly to the IHSGCA in the way other elected member of the Hall of Fame have. No, Rob gave much more in fact!

While at the White House to witness President Obama awarding Rob the Medal of Honor, I had the opportunity to meet and talk at length with Rob's team captain in Afghanistan Major Cusick, the man Rob directly saved

As Major Cusick and I walked out of the White House, together he recalled the battle in the Kandahar Mountains on that cold January day. As his team was drawn into a fire-fight with the Taliban forces, Major Cusick was hit and Rob jumped into his vehicle and embroiled the enemy with its mounted "MK19 40 millimeter automatic grenade launcher" to protect Major Cusick. Rob pursued the enemy using up weapon after weapon at his disposal. He advanced on the enemy drawing their fire away from his team. While still calling out the coordinates of the enemy in both Pashtu and English Rob was shot. He, however, did not cease to pursue the enemy and draw their fire.

That is when in the shadowed outline of the White House, Captain Cusick stopped, grabbed my arm looked me in the eyes and said, "I don't know what you taught Rob in high school but if it weren't for him, I wouldn't be alive today. I wouldn't be here. I know you had a profound impact on him because he talked about you and his experiences at your school. And, if it weren't for him, I wouldn't be here." He went on to tell me that he hoped to be a high school P.E. teacher one day because he believed that it was in high school leaders were made.

I realized that Rob had achieved something great within himself. As I thought about my conversation with Major Cusick, when he thanked us for teaching Rob something, I awoke to the epiphany that we as coaches, and educators had a powerful effect on Rob's character which led to his actions that night on the battlefield. We had a profound effect on the development of Rob's ideals of virtue, his ideals of service, and his actions which embodied those ideals. We teachers, coaches and mentors had a great impact on Rob's leadership abilities. Our coaches association contributed to Rob's development as a leader by upholding the virtues, the rigor of our sport and the opportunity to compete in high school gymnastics in Illinois. Rob may be considered our greatest success story!

Surely, the committee applied the rules which they were elected to uphold, and to legislate; however, in the case of Rob Miller the rules were applied to someone who served above and beyond those standards.

The elected Hall of Fame committee did their duty in regards to the law; however, I believe that as elected

people they also need to balance the law with their own humanity. They are elected not just to uphold and protect the standard of the rules but to also bring the human element of wisdom and flexibility to the committee. They are elected to look at nominations with a human eye.

Even in our courts of law, the law is to be tempered with humanity, hence a jury of peers. So also, the Hall of Fame committee is elected from a body of members to do the human action of balancing the law, the rules, with that which serves a higher good, a higher right, a higher justice—not just the law.

In Rob Miller's case his sacrifice, his actions, and his being a awarded the Medal of Honor—the highest military decoration awarded in our country—rises above and the content of the rules guiding the Hall of Fame committee. I would ask the committee to reconsider Rob Miller to be nominated to the Hall of Fame in a special session this year.

CONSTITUTIONAL AMMENDMENT

Article XIII

Hall of Fame

Guidelines for the Illinois High School Gymnastics Coaches Association Hall of Fame.

- A. Location Gary Morava Center, Mount Prospect, Illinois.
- B. Purpose To recognize the achievement of those people who have contributed to the promotion of Illinois High School Gymnastics.
- C. Categories Competitors, coaches, judges, and contributors.
- D. Criteria:
 - 1. Any member of the Illinois High School Gymnastics Coaches Association will be eligible to submit nominees.
 - 2. Any member making a nomination will be responsible for writing a resume of the nominee's accomplishments and contributions to Illinois high school gymnastics.
 - 3. All nominees in the coach, judge, or contributor category must have a minimum of five years active participation in the Illinois high school gymnastics system.
 - 4. All nominees in the competitor category must have completed at least one year in the Illinois high school gymnastics system.
 - 5. All resumes will be submitted to the Hall of Fame Selection Committee in January for screening, with a majority vote by the Selection Committee needed to approve the nominees of the membership.
 - 6. An individual nomination is active in the HOF committee for three years.

7. All resumes should be kept on file indefinitely.

E. Hall of Fame Committee:

- 1. The selection committee will be composed of six members to serve a term of three years.
- 2. A chairman will be selected by the committee with a simple majority vote.
- 3. The Hall of Fame selection committee will review all current nominees.
- 4. A majority vote by the selection committee is needed to approve current nominees of the membership.
- 5. A 2/3 vote by the selection committee is needed to reject any nominee of the membership.
- 6. In February the Hall of Fame committee will meet to review names for the current years ballot.
- 7. The selection committee will present the nominees to the entire Association at the March meeting.
- 8. A ¾ majority is necessary to be introduced to the selection committee once again for final approval.
- 9. The number of inductees shall be of a number not to exceed three in any year.
- 10. Announcements of inductees will be made in conjunction with our annual banquet at the May meeting.

F. Hall of Fame Chairman:

- 1. The chairman will annually update the Hall of Fame members and their personal contact information.
- 2. At the December meeting the Hall of Fame chairman will review all resumes on file that can be renominated by the general membership.
- 3. The second week of April, the Hall of Fame chairman will send out ballots and resumes to all Hall of Fame members that are not actively coaching at a member school.
- 4. The ballots must be on colored paper.
- 5. A stamped, return envelope addressed to the Hall of Fame committee chairman will be sent with the ballots.
- 6. Current Hall of Fame members will vote by mail only.
- 7. Current Hall of Fame voting ballots must be returned before the end of IHSA Sectional competition.
- 8. The chairman will write a formal letter to the individual(s) notifying them of their acceptance into the IHSGCA Hall of Fame.
- 9. The chairman will arrange for the HOF member to provide an 11"X14" black and white portrait. He will frame and place the photograph on the HOF wall at the Morava Center.
- 10. The chairman will coordinate with the HOF member in ordering a ring.
- 11. The nominee will pay 50% of the cost toward purchasing the ring.

12. The chairman will send a letter of recognition to the Principal and Athletic Director of the high school in which the inductee coached.

G.Hall of Fame Voting:

- 1. The Hall of Fame steering committee prepares the Hall of Fame ballots.
- 2. At the end of the April IHSGCA meeting the Secretary-Treasurer will prepare for the Hall of Fame steering committee a full membership list with school names. The list will include current Hall of Fame members that are actively coaching.
- 3. The Hall of Fame steering committee or their appointee will conduct voting for the Hall of Fame at all sectional host sites.
- 4. There is no limit on the number of nominees that can get a "yes" vote.
- 5. All ballots are forwarded to the Hall of Fame chairman and kept separate from the current Hall of Fame member ballots.
- 6. Using the total number of Full members, tally 75% of this number to determine the votes necessary for induction into the Hall of Fame.
- 7. The final vote count is made using the "yes" votes from the current Full membership plus all "yes" votes from current Hall of Fame members.
- 8. Per XIII-E-8 from above the Hall of Fame committee will tally votes and notify in writing the IHSGCA President of the individuals inducted into the IHSGCA Hall of Fame.
- 9. The Hall of Fame chairman will keep all ballots for one year.

Article XIII Section D

A candidate will only be approved if he receives a 3/4 majority (75.0% or greater) of all votes cast. Hall of Fame members' votes will be counted the same as general Association members' votes.

The Hall of Fame committee shall count the votes as follows:

- A "Yes" vote for a candidate will be added to the vote count's numerator and denominator.
- A "No" vote for a candidate will be added to the vote count's denominator.
- An "Abstain" or non-vote (neither "Yes" nor "No" were selected) for a candidate will not affect the outcome.

Example:

Candidate X receives 35 "Yes" votes, 10 "No" votes, with 7 abstaining. The votes are calculated as 35/45 = 77.8% and the candidate is approved for Hall of Fame induction.

Candidate Y receives 20 "Yes" votes, 8 "No" votes, with 8 abstaining. The votes are calculated as 20/28 = 71.4% and the candidate is not approved for Hall of Fame induction.

The Hall of Fame committee shall notify the Association president the result of the votes by _____(some time frame).

Changes to State Meet Format:

The following were voted on and pass unanimously to suggest to the IHSA for changes in the State Meet format.

Proposal for team finals

1. All-around groups will be assigned to each of the BYE rotations in the 8 team rotation currently used with the BYES starting first on two of the 4 rotations instead of the present none.

Rational, it is chosen at random for the team, the AA should also have a feel of randomness to better show the openness of the judging.

2. All-around groups will be assigned in descending ranked order and be assigned each of the 4 slots. The exception being all-arounders from the same team should be in the same rotation for the purpose of safety and saving time so a coach does not have to be on two events at the same time.

Every effort should be made to keep the groups as close to the same number as possible

3. Team warm-ups will be 12 minutes per rotations as per sectionals
