## Club gymnast eligibility:

- Keith: Clarification on "directly sanctioned"
  - After discussion with Tracie Henry, USAG-sanctioned meets like the Joe G Invite should pass the IHSA's rule 3.10, but eligibility is ultimately determined by the IHSA Executive Director, Marty Hickman.

#### Coaches' To-Do List:

- Rate your officials!
  - o All officials need to be rated for **every** meet. So in an invite, you should rate 6 judges
  - Officials can't rate officials anymore
  - o The ratings influence who is eligible to judge state series next year.
- List of participants due to the IHSA: April 21<sup>st</sup>
  - o Keep a copy and print it out for Sectionals
- 2015/2016 rules proposals must be proposed at the May meeting
  - Will be discussed in Nov., voted on in Dec., then goes to IHSA for approval. So new rules will not go into effect for 2 years.
    - Changes to Freshmen rules will now be a part of the formal rules proposal process since they are now part of the official IHSA rules book.
  - o Formal procedure if an official is a no-show.
  - 0 ...

## IHSA Advisory Board update

- Approved both proposals:
  - Alternates for state—notify IHSA by Thursday before 4 pm if a state qualifier will not compete. The next place finisher(s) will be pulled up and entered into the meet.
  - 15 minute warmup block to be shared at sectional and state meets
  - Both would go into effect **next** season, if approved by further IHSA review boards.
- rating of officials by coaches is very important!
- To form/maintain a co-op, an application must be submitted to IHSA. A new change is that the co-op must be approved by the conference before the IHSA will accept the application.
  - o Co-ops must submit applications every two years.
- Tim Hamman will be the new IHSA Advisory Board Rep for the 2015-17 seasons.

#### Judging:

- Update on unfilled slots
- Anyone who can should sign up for open slots

- Note from Doug Foerch: Sheets with routines for judges were for instructive purposes at the beginning of the season and feels they should now be phased out. It's inappropriate to approach an official during a meet so they should only be presented **before** the meet starts.
  - O Discussions with judges should be had *after* the meet.
  - Note from Keith: I'm still very much in favor of the sheets, provided we follow Doug's guidance to only submit them before the meet starts. The Steering Committee will discuss this further with Blaise and Doug to provide guidance for the remainder of this season and hopefully establish protocols/recommendations for next season.
- 58 total officials this year:
  - 35 are at beginning level of "registered"
  - 1 is "recognized"
  - o 22 are "certified"
  - 8 officials did not renew from last year
  - o 14 new officials this year for a net gain of +6 officials.
- IHSA wants to get more younger judges/officials
  - Every recognized institution will be able to get two exemptions/waivers to get two judges registered for free.
    - Each AD will get two of these to use for officials/sports of their choosing
    - Our coaches association will get two of these
- There is a proposed IL law that would have the State Board of Education take over the IHSA.
- Start values should be displayed at Conference and Sectional meets
  - Conference and Sectional hosts should have an extra set of score flashers to display start values.
    - So these schools will need 12 score flashers or some system to display start values.
- Rules on inquiries can be found in the IHSA rules book:
- 8. Inquires: At championship meets, two written inquires are permitted. A third inquiry is permitted if one of the first two inquiries is upheld.
  - The inquiry may only pertain to difficulty, element group requirements and bonus. A 0.5
    deduction shall be taken for any illegal inquiry.
  - 2. The inquiry shall be submitted no later than seven minutes after all scores are recorded in that rotation.
  - 3. The inquiry shall be given to the meet director/meet referee, who will give all legal inquiries to the event judges for review. The judges may consult with the meet referee, however, there shall be no video review.
  - 4. Decision of the judges at the conclusion of the inquiry is final.
  - 5. If a second inquiry does not result in a score correction, a 0.5 deduction shall be taken from the team score. If there is no team affiliation in the competition, the deduction will be taken from the individual's score on that event.
  - When more than one inquiry is submitted on a given event, the coach shall receive the outcome of the first inquiry and must then inform the official whether to proceed or withdraw the subsequent inquiry.
