Vision:

Membership drive

Frank: Change the designation of registered IHSA officials from Associate Membership to Full Membership.

Constitution:

Article III

- Part. A. Full Membership
 - 1. All boys' gymnastics coaches who are presently employed by an accredited high

school in the state of Illinois and officials who are actively judging are eligible for Full Membership

a. They will have a voice in all Association matters.

b. They will have a vote in all Association matters.

c. They will have a vote in Hall of Fame matters.

d. They will pay annual dues by the second attended Association Meeting

4. A Full member must be present at two Association meetings prior to the May meetings.

a. If a full member is not present at two association meetings prior to the May meeting, he will lose his voting privileges on Association Matters.

6. Only a Full member can initiate a motion, proposal, resolution, amendment, rule change, or second the same.

* Pro and Con with vote at March meeting.

Con: Eric Liva: The system that has been in place has worked for so long so why change it? What is the purpose to giving the judges equal value in the association?

Pro: Blaise Blasko: Judges and Hall of Fame members have never tried to come together on anything that is bad

for the sport.

Fundraising:

Rating officials

*Remember to rate all of your officials for every Varsity contest you have and be current with it don't wait until end of the year to rate all of them at once.

Rules proposals (This is for any proposals to change rules with in the current book)

*All rules proposals will be at the May meeting for potential implication in Jan of 2017

*The November meeting will be for discussion of the proposed changes

*The December meeting will be for a pro and con along with voting

-Jarrod Amolsch started discussion about the rule book and that at the start of the season the rule book should be clearly followed and if it is stated one way and a trick that is performed meets the criteria then it should fill the element group/count as a credited skill. This is in hopes to eliminate confusion for both coaches and judges. Currently there have been situations in the FIG book that very generally state what needs to be seen but when a gymnast performs a trick that "technically" fulfills what needs to be done judges have said "Well that is supposed to mean this..." If it can be written exactly as what the judges are looking for then this would hopefully eliminate potentially subjective evaluations that judges would have to make.

-Someone asked what the results of the vote were tonight.

Results: (13 in favor) and (15 against)

(After the meeting it was noted that the two proxy votes that were submitted were by ineligible voters and their votes would not count. Therefore the official vote count was 13 in favor and 13 against)

-After the results of the vote a Constitutional proposal for Judges to be able to become full members was made by Frank Novakowski

Second by Zach Crandall

-Discussion ensued about the legality and appropriateness of proposing something right after it had been voted down by the group that had been present to vote.

-A constitutional proposal can be made at any meeting and follows a three meeting schedule before the vote. -After discussion about the pros and cons of the current proposal Frank proposed to remove his previous proposal and it was seconded by Zach Crandall.
