IHSGCA Constitutional Amendment:

Article XIII, Hall of Fame, Guidelines for the Illinois High School Gymnastics Coaches Associations Hall of Fame, Section D. Criteria

9. Nominees shall remain eligible for consideration for a three-year period. If the three-year period expires without being inducted, the individual must be re-nominated (with a resume).

Scott Phillips pointed out that some current names may be unknown to newer coaches and may need to be re-nominated and resumes updated. Furthermore, perhaps it would help to standardize the resume format to include more detail than is currently provided. This template would appear on the website much the same as senior gymnast nominations.

New Business:

1. Frank has received emails regarding club gymnasts and/or their coaches failing to comply with IHSA guidelines with respect to competing for, and working out at, their clubs. Frank also was contacted regarding "rules violations", the nature of which are somewhat nebulous.

Discussion ensued relative to the possibility of existing ethical violations and how our Association should act on such infractions. Perhaps our Steering Committee can at least discuss how to address these situations, if not act on them by approaching the coach whose methods might be in question. It was generally agreed that we are obligated to govern our coaches and their programs. In addition, involving the IHSA on such "in-house" issues might be unwise as it may send the wrong message.

It was agreed that it is incumbent upon each coach to not only know the existing rules and guidelines, but to adhere to them as well. It was also suggested that these rules be reviewed at all IHSA Rules Interpretation Meetings thus reaching all coaches. The Association appeals to each coach's sense of fair play to abide by the rules set down by the state.

Doug and Scott Hagel will put together a synopsis of what coaches need to know about such matters. This memo will be forthcoming.

- 2. Greg brought up the current sectional seeding system. Brad reported that the IHSA apparently ignored the suggestions of the Advisory Board to seed out to 10 places. The suggestion to seed all teams is currently going to the Board of Directors.
- 3. Steve brought up the practice of using one-hundredths of a point to differentiate between routines at invitationals in an effort to save on medals. His opinion is that this is not only unfeasible and inaccurate, but patently unfair. It was pointed out that this increasingly pervasive practice has far-reaching effects such as national team average and all-American status. Suggestion: by providing duplicate medals, the host school will incur minimal expense which can be passed on to the visiting schools. Rationale: this will allow judges to have multiple ties thus providing the gymnasts with their rightful score and place and avoid the judges "bumping" the gymnast up or down in the final placing.
- 4. Greg suggested the Rules Committee revisit the use of bonus to differentiate scores particularly in higher-level routines.
- 5. Chris Stevens inquired as to how many contests an individual must participate in to be eligible for state series. The tentative answer seemed to be two.
