- o Criteria for Senior Gymnast
 - 1 nomination per school
 - Must have 3 consecutive years of participation in IHSA gymnastics
 - The gymnast must demonstrate leadership, citizenship, good moral and ethical behavior, and loyalty to Illinois high school gymnastics
 - Gymnast must compete in the entire state series (unless they do not advance due to not making the cut or injury)
 - Gymnast must have a 3.0 GPA or higher, or be in the top 1/3 of their class.

o Criteria for National Team

- Gymnasts must compete in the entire state series (unless they do not advance due to not making the cut or injury)
- Gymnast should possess good ethics, character and sportsmanship.
- Gymnast must have competed 3 years of participation in IHSA gymnastics (not consecutively).
