# **State of Gymnastics in IHSA**

### **Updates from IHSA**

- State Meet is set and at Hoffman Estates again
- o Review year for participation numbers down last year in teams
- o Rules Book Update
  - We are good for one more season under the "old book"
  - NFHS no longer backing our book following this season
    - USAG has agreed to back our book along with modifications

Individuals do count as a "program" but the IHSA will look much more favorably on a full team. Teams of 3-5 athletes. Frank Novakowski spoke with the USAG President, and he agreed to support our rulebook which is level 9 with a few HS modifications. In the long run, cutting out the NFHS removes a step involved in the approval of our yearbook while still maintaining recognition from a national governing body.

• Keith Mukai is the officiating rep and Greg Gebhardt is the coaching rep on the advisory board. First years as reps to the IHSA - communication with them about our current state as a sport.

#### **Updates from the President**

- IHSGGCA (Girls Gymnastics Coaches Association)

# **Judging**

### **Updates**

- A couple retirees this year, so we're going to need people to pick up the slack
- Only 28 current registered judges, down from 40+ last year and the year before.
- Only 9 certified "state-ready" judges
  - Anybody that is eligible for a promotion should apply to be promoted
  - F novakowski: Make sure that you see the Hate Speech presentation in order to be on the list.
     Frank has emailed everyone who looks eligible for promotion to remind them to apply for that promotion.

### Recruiting/Signing-up

- Please sign up if you have not.
- First year judges do not have to pay a late fee
- It might be a good opportunity to try to reach out to Club judges and see if they'd be interested
- Ideas to get more judges?!

We should get more assistants to sign up to make it easier to take that next step once they're ready to begin judging, if not simply for appearance's sake.

Blaise: Point of Discussion: of those 9 officials (eligible for state series), how many of them will have teams in the competition. There will hypothetically be 6 officials with experience and eligibility to judge the state meet. That is not enough. How do we get officials to gain the experience necessary to judge the state meet - what can we be doing to ensure quality is there from the judges if not the necessary experience.

Ryan Dul: The simplest answer at the moment is for coaches to RATE your OFFICIALS.

GGebhardt: Head coaches have to judge. We need coaches who can judge. Coaches with experience who know what they're doing so that we as coaches can have confidence in the official sitting in the chair judging the athletes in the finals. We can zoom judge routines to practice. It was easy, convenient, and provided experience.

K Mukai: Can we work with the assignment chairs to help keep the Varsity invites judged by younger, but promising judges in order to get their experience in big varsity meets rather than the already experienced judges?

Gebhardt: it is hard enough as the assignment chairs to cover all the meets without trying to assign and deny specific judges to the meets.

Blasko: Makes a motion that every coach attending the meeting tonight be put on a list to undergo training in order to make them state qualified officials.

How do we administer this? Getting the coaches here trained to judge now, this season? How Many training sessions are necessary?

Howie Sokol: Necessary to move the meet start times back to 6:30

Zoom Training sessions on Saturdays. Can we get coaches to run them?

Brandon Tucker: practice judging at your own team practices

Dul: mini clinics at the end of association meetings 5 association meetings before the state meet.

Blasko: Is it possible that Greg, Keith, Brandon, Frank, Adrian be a judges committee to speak at our December Clinic about implementing some of these suggestions.

Harima: judging clinics are a lot of information to take in at once; if judges can break down the volume of information and increase the frequency of the clinics, it may be more effective.

All of the volunteers have agreed to meet as a small committee and make a recommendation regarding the path forward and the above suggestions to train judges this upcoming season.

Blaise Blasko, with the formation of the committee, has withdrawn his motion to get all coaches present tonight to sign up for training sessions this season.
