Future of Gymnastics

Moving beyond high school presented by Josh Levin

Possibilities for out gymnasts beyond HS - Anyone who wants to do collegiate gymnastics can do that through GymAct. Northern Illinois - no cuts, opportunity provided for anyone who wants to show up and participate. Even if they do not make the top 5 competitive lineup, there will be opportunities for them to compete - i.e. the Pineapple meet. NIU is not the only school in the area that offers GymAct team - UIC also does. NOTE: You do not need to be a student at the school, you just need to be going to a school (12 credits, 6 credits per semester) and you can participate on a team. The sport is not a dead end after HS, there are opportunities to continue on in the sport post HS. WE need athletes to continue with the sport after HS so that they can continue to help grow the sport after college.

Updates from IHSA

- State Meet is set and at Hoffman Estates again Believe to be the last year here. Hoping Niles West will be the new location for the next 4 years.
- Review year for participation numbers down last year in teams Hinsdale Central looking for a head coach. Stevenson looks like it will have a head coach this 21-22 season
- Rules Book Update



- We are good for one more season under the "old book" The rule change of allowing the vault to be lowered will not be able to be implemented on the "old book" and will have to be added into the next years rule changes.
- NFHS no longer backing our book following this season
 - USAG has agreed to back our book along with modifications Jason Woodnick (USAG vice president) has agreed to have USAG endorsement of our book allowing for modifications. Important to understand that boys gymnastics now operates under the National rulebook, not the NFHS. important to ensure your AD's understand that. USAG will do updates once a year in November and will try to stick with those for the entire competition season. This will help us because there will be no more mid-season rule changes.
 - From November's Notes:
 - Individuals do count as a "program" but the IHSA will look much more favorably on a full team. Teams of 3-5 athletes. Frank Novakowski spoke with the USAG President, and he agreed to support our rulebook which is level 9 with a few HS modifications. In the long run, cutting out the NFHS removes a step involved in the approval of our yearbook while still maintaining recognition from a national governing body.

Updates from the President

- IHSGGCA (Girls Gymnastics Coaches Association)
 - They are under new leadership and willing to bridge the gap that exists between our associations. This is good for the health of our sport in general. Other positives/benefits that could occur from a mutual relationship:
 - More potential coaches & judges for Boys Programs
 - Increased potential to start boys programs for schools who ONLY have a girls programs The IHSGGCA Coaches can communicate, promote, and support to their AD's

- Only 28 current registered judges, down from 40+ last year and the year before.
- Only 9 certified "state-ready" judges
 - Anybody that is eligible for a promotion should apply to be promoted

Judging Committee

- Recommendations: 3 categories of people who are UNABLE to judge.
 - 1. People who cannot commit.
 - 2. People who genuinely do NOT want to do it.
 - o 3. People who want to do it, but feel they are not ready.

Committee has decided to run a survey to find out who is in what category.

Hoping to address those who respond with #3 in two ways, 1) What can we do to help get you prepared? How can we enable you to be successful? And 2) Get them to accept that there is only one way to get prepared and that is through experience by participation and emphasize the need for them to begin judging otherwise coaches will be forced to judge their own meets. In other words, accept the inevitability that they will have to start judging regardless of their feelings on preparedness.

Possibility of setting up invites that force coaches to judge those routines and make it a prereq of the invite to judge, and force them to gain the experience of sitting in the chair.

Did the committee discuss the use of retired judges or HOF members to help sit with coaches who are learning to judge to help talk them through it?

Response: if you are volunteering we will be happy to go that route.

Ideas & Suggestions regarding to supporting/promoting our sport

Bill Cordts - Discussion on having a two-level state meet.

This is based on how Louisiana and Texas run their state boys gymnastics programs. Running a compulsory routine format state competition and an optional format will help to level the competitive playing field and get as many kids awards as possible. Promotes good, disciplined gymnastics. Operates under the USAG rules. Helps kids transition from the club to the HS competition meaning the club level compulsory would be the same as the HS compulsory routines. Clarification: compulsory is not replacing optional, but is working in tandem with the optional routine.

How would teams competing compulsory routines at one level match up with teams competing compulsory routines at a different level?

Is the suggestion that teams would be either compulsory vs optional? Or both? Should the state meet be a joint competition or separate state meets?

Can teams be mixed optional and compulsory? No, the decision whether you are optional or compulsory must be defined . When would this decision be made?
