Judging

Updates

• Number of current registered judges

- We are up to 45 registered officials. There were 39 at our last meeting.

- There are still plenty of open spots to officiate meets currently. Please contact Greg Gebhardt and/or Bob Russell for what is currently available if you are.
- Follow-up to "Meets being Affected by Lack of Judges & How It'll Affect You" Email.
 - \circ ~ In the Q&A \ldots judging while spotting issues.

"If a coach must act as a judge then he <u>cannot</u> act as a spotter. If there is no suitable Assistant coach present to take their place as spotter, or the athlete does not feel safe with another spotter, or the Assistant coach does not feel capable of safely spotting any given event, skill or athlete, then one of the following must occur:

1. The skill should be removed from the routine or replaced with another "toned down" skill that the athlete feels comfortable executing with the assistant coach spotting.

- 2. The athlete(s) do not compete in that event.
- 3. The meet does not continue and all teams forfeit.

The above situations must be considered and addressed PRIOR TO the start of the meet."

- Any questions in regards to the scenarios listed?
 - This is not ideal and leaves unregistered officials who are also coaches at an advantage because the coach who is a registered official won't have to potentially sit an athlete or water down a routine

Gebhardt - Has encountered his first meet where he will not have a full judging lineup. He emailed the AD suggesting a new structure on how the triangle meet should operate. The AD was not happy... asked if he could reschedule, was confused as to why this is happening...

Also, please give new judges a chance. The last thing any new judge, or really any other coach wants to hear from another is, "why doesn't the guy behind the table know what he is doing?" It doesn't help. It's unproductive, It makes new judges feel bad, and it's caused by a situation that we're all contributing to.

Rule Proposals

Rule Proposals Procedural Change (for this season)

Considering the impact of the new code coming out this year, it is best that rule proposals are collected by the Executive board and proposed to the Association in March. A discussion will be held in the April meeting so that

potential proposals can be heard and rationale be given, but there will be no vote on them in May. The proposals will then be submitted to the rules committee and while the new code is analyzed and worked through by the rules committee, they will simultaneously be examining and considering the proposals originating from the association. There will be no vote by the Association in the year that we transition to a new code book.

Rationale for this decision:

- The Rules Committee wants the input of the Association, but space has to be given to that committee to interpret the new code first before rules proposals are voted on by the Association. Updated rules will have to be presented at the Winter Clinic, and it will be a very tight timeline to expect the Association (and the rules committee) to submit proposals, receive votes, incorporate them into an updated book, and get USAG to approve the book if we move back the voting timeline to December.
- It will be best to postpone rules proposals for the first year of a transition year to a new book. Let the Rules Committee lay out the book for the first year, allow discussion at the April (2022) meeting, so that the committee can hear rationale before they go to work on writing the new book.
- This is what was done the last time we transitioned to a new book.
- The extenuating circumstances that have kept us on the same book for the past 5 years, and the difficulty that transition entails.
- It also prevents repetition

Large discussion around the merits of voting on the year of a new rulebook

- Where does the SC get the power to make this decision? The association should be able to still have a voice and be able to vote on proposals. If we take away voting, we take away all of our voices. If we do not follow the constitution what is the point of having it?
- Steering Committee will look into this matter again and let the association know about any decision made next meeting.

- The book and code is already out and we have the ability to look at it
- But how many people have looked at it this year? Not a whole lot. The Rules Committee hasn't started on it either.
