Updates from IHSA

Timeline since our last meeting

- A letter was sent to the IHSA BoD explaining why gymnastics is so necessary for our kids. No response from the Board... (No response from BoD, Tracie Henry did respond)
- Meeting with Krystin Campos (IHSGGCA President)
 - We will work together on this:
 - Contacting gymnastics clubs
 - Using Social Media to support one another
 - Very positive and supportive meeting
 - Spoke together at the Girls Association, explaining the importance of being united
- Spoke with Tracie Henry. She said that she would try to set up a meeting with some members of our Association. She mentioned:
 - Other "emerging sports" are looking at Boys Gymnastics and saying "Our numbers are comparable or better. Why don't we have a State Series?"
 - Compared it to a class not running due to numbers not being there
 - It would be in our best interest to not ask for a change in policy
 - There would not be an opportunity for questions to be asked
 - We would simply present our case of why gymnastics is needed and all of the positives that it provides. The Board could then ask questions to us if they want after
 - Meeting would take place sometime between now and June
 - Some AD's are looking for an earlier decision than June, for budgeting, summer, etc. Our timeframe may be changed and much earlier than the June deadline
- WGN aired a segment outlining our situation (on the IHSGCA Instagram Page)
- Efforts by Betty Axelson-McClelland
 - Contact with Chicago Park District
 - Working with Betty Axelson to help us. She continue to be an unbelievable support of boys gymnastics

 - Gymnastics Clubs

 - What should you say when calling
 - Prompt for club gym calls
- Possibly reaching out during the Pineapple Invitational Early December, Schaumburg Convention
 Center Renaissance. Didech said we can have a table at the meet. 12/16-12/18

 - Have students use personal email if possible, but coaches should speak with the AD and know the school's stance. If the AD at your school says not to use school email, then follow your AD's directions. Please discuss with your school's admin.
 - It has been recommended (Tracie Henry) that we push testimonials AND a viable plan to increase teams in the sport.
 - Costa- what comprises a team...3 events at varsity + must compete in 6 meets, virtual meets are allowed They do not necessarily have to be live. (a team could compete in a tri or quad meet and get 3 to 4 meets in one competition)
