Rulebook 2025-2028

Clarifications:

- Rule 2.II.C.1.a The word "dismounts" has been changed to the word "skills".
 - On Floor Exercise <u>All multiple (more than one)</u> flipping and/or twisting <u>skills</u> will receive
 0.1 bonus if performed without a single large deduction on Floor Exercise
 - This was the original intent of the additional bonus.
- "Pillow mats" will not be acceptable for use in competition.

CONSTITUTIONAL AMENDMENT PROPOSAL

- Const. Amendment regarding the HOF cycle and the reserve of funds in the case the sport ceases (will be voted on next week (2/3s majority of voting members of association to pass constitutional amendment))
 - Fig. 10 Amendment
 - O Key Points:
 - Money is put aside in a lump sum (this year) to cover the cost of 3 years of HOF Banquet in the case that the IHSGCA season ceases to operate
 - Estimates on how much would need to be moved over ~\$650-\$1,100 per year for the HOF banquet x 3 years would be \$2,000-\$3,300 moved to a separate account, or a savings account to be overseen by the HOF Committee.

- To clarify, would this be deposited as a lump sum or in parts? Upon dissolution, this year, or every year for the next 3 years?
- That reserve will be looked after by the HOF committee to ensure that the Banquets continue for 3 years
- Options to push up the voting to earlier in the season are being looked at by Scott Phillips.
- Is it possible to include the option whoever is being inducted has the opportunity to defer their induction banquet for a year to allow for time to invite family and friends from out of town, or keep it the same year they are inducted. #10- "Or may choose to defer their induction ceremony until the following year"
- Could it be changed from "non-active coaches will vote by mail only" to "non active coaches will vote electronically or by mail"?
- "IN ESCROW" will be changed to "In Reserve"
